As a municipal arm of government our purpose is simple – Together we provide drinking water and wastewater service to the community.

Our employees are dedicated to public service through **Caring, Innovation, Collaboration, Leadership and Stewardship,** and we are looking for a qualified candidate who shares our values to join our team in the role of **Wastewater Operator.**

The Wastewater Operator provides operation, maintenance, and repair of the wastewater treatment plant.

Duties:

- Plant operations, laboratory testing, cleaning: clarifiers, bar screen area, digester, and drying beds.
- Participates in keeping the Treatment Plant compliant with the EPA's Risk Management Plan, TCEQ's Storm Water Pollution Prevention Plan permits, and implementing a district FOG/Backflow program.
- Collect and run daily/weekly samples and storm water sampling as required by TCEQ.
- Ensure proper chlorination and de-chlorination. Makes plant inspections, takes readings: totalizer, water meter, flow meter, and hour meters on various equipment.
- Complete monthly reports for wastewater intake/output averages and weekly reports for daily averages.
- Provide routine maintenance and grounds keeping as needed in the plant.
- Changes out empty chlorine cylinders, sulfur dioxide cylinders and polymer drums as needed.
- Performs all other related duties as assigned.

Minimum Qualifications:

- High school diploma or equivalent (GED).
- Possess valid State of Texas Driver's License with acceptable driving record.
- Two years of related experience.
- Computer literate in Word, Excel, GIS mapping and SCADA.
- Must be able to respond on site to call outs within 30 minutes.
