- 4. If a standby fee is imposed by the District, the amount of the standby fee is set forth in the form of Notice to Purchasers contained in <u>Exhibit "A"</u> attached hereto and made a part hereof for all purposes, as same may hereafter be from time to time amended.
- 5. The District was created on May 1, 1939, by the State Board of Water Engineers (a State Agency that was a predecessor of the Texas Commission on Environmental Quality).
 - 6. The functions performed or may be performed by the District are as follows:

Purchase, operate and maintain all facilities, plants and improvements necessary to provide water and sanitary sewer service for the residents of the District.


